NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- Prohibited Right-hand turn except for pedal cycles on part of Surrey Street;
- Prohibition of Motor Vehicles on parts of Barkers Pool, Black Swan Walk, Exchange Gateway, Fargate, High Street, Leopold Street, Norfolk Row, Pinstone Street and Surrey Street;
- One Way Traffic (with pedal cycle exemption) on parts of Fargate, High Street, Norfolk Row and Surrey Street;

And remove:

- Prohibition of Vehicles on parts of Exchange Gateway, Fargate and Norfolk Row;
- One Way Traffic on parts of Fargate and Norfolk Row.

A copy of the proposed Order, a plan showing the roads concerned and a statement of the Council's reasons for proposing to make the Order may be examined during normal opening hours at First Point Reception, Howden House, 1 Union Street, Sheffield, S1 2SH or on the City Council Website at www.sheffield.gov.uk/home/roads-pavements/traffic-orders.

STATEMENT OF REASONS

Future High Streets – Fargate

The proposed TROs compliment the new public realm scheme for Fargate. The enhanced public space incorporates raise and lower bollards that will only allow vehicles to access Fargate at certain times for loading/unloading (except for exemptions) and, together with the proposed One Way traffic restriction with pedal cycle exemption (cycle contraflow), will control motor vehicle movements within the newly defined public space.

Please Note; this scheme is being readvertised to incorporate changes from the first TRO advertisement consultation in October 2022.

The Sheffield City Council (“the Council”) in exercise of its powers under Section 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124 (1) (c) (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into operation on the _____, 2023 and may be cited as The Sheffield City Council (Fargate Area, Sheffield) (Prohibition of Motor Vehicles and One Way Traffic) Order 2022.

Definitions

In this Order:-

“Permit” means a permit issued by the Council and used in a manner directed by the Council.

“Road” has the same meaning as that in section 142 of the Act.

“Traffic Sign” means a sign or marking of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Act.

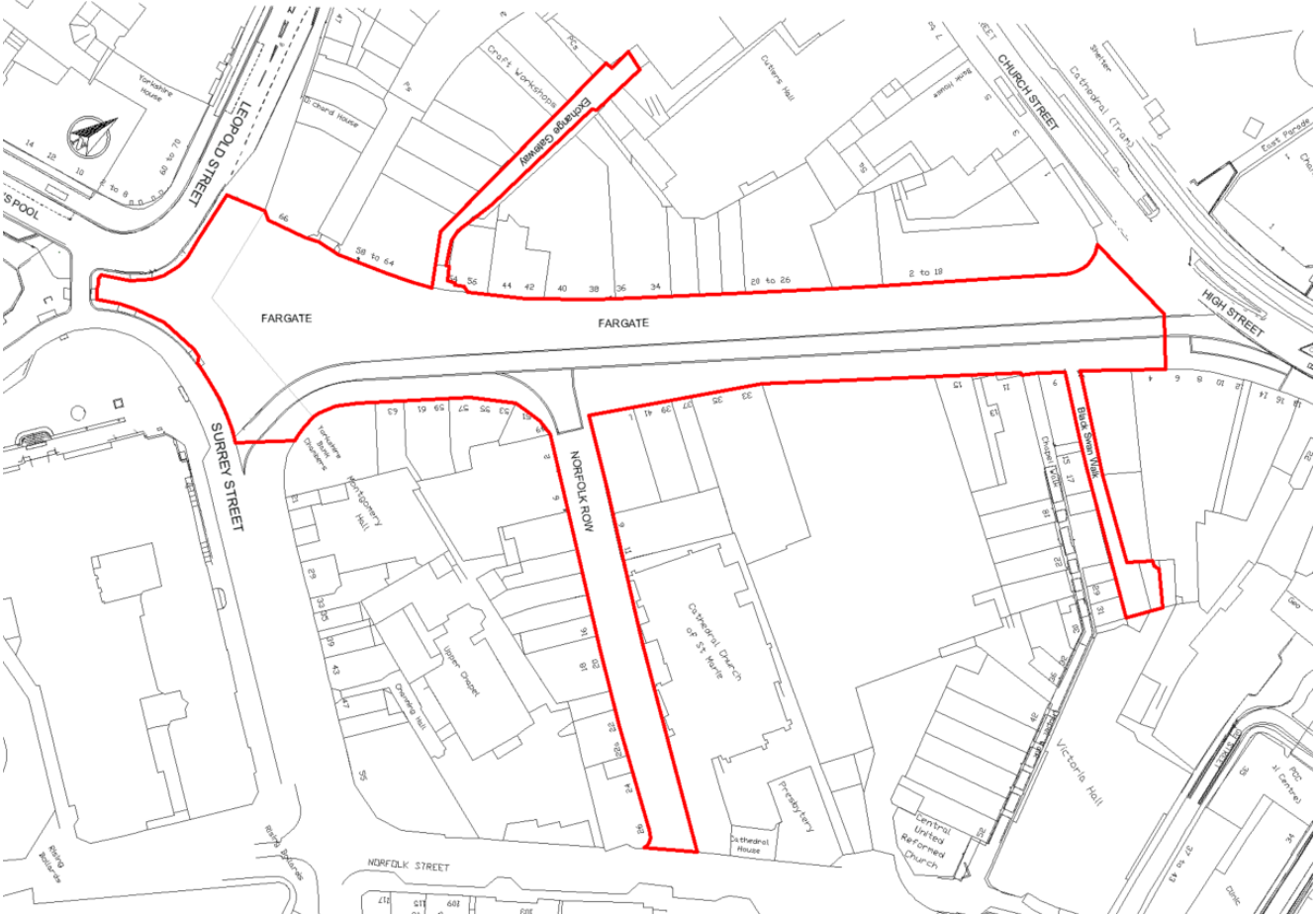
2. Save as provided in Articles 3 and 4 and subject to the provisions of Article 5, no person shall cause or permit any motor vehicle, except upon the direction of with the consent of a police constable in uniform, to proceed in that area of Road confined by the boundary set out in the plan included within the Schedule to this Order.
3. Nothing in Article 2 shall render it unlawful for any motor vehicle to proceed in that area of Road confined by the boundary set out in the plan included within the Schedule to this Order if the vehicle is:-
 - (a) displaying a Permit issued by the City Council;
 - (b) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely –
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said road; and
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said road of any sewer or of any main, pipe, line or apparatus for the supply of gas, water or electricity or of any line which is, or forms part of electronic communications apparatus as defined in the Communications Act 2003;
 - (c) an official vehicle approved for use in wedding or funeral ceremonies by its organisers;
 - (d) being used in an emergency for ambulance, fire brigade, police or local authority purposes.
4. Nothing in Article 2 shall render it unlawful for any motor vehicle to proceed in the Roads referred to therein between midnight to 10.00 a.m. and 6.00 p.m to midnight, if:

- i) that vehicle is taking access for the purposes of loading or unloading at premises; and
 - ii) the Council has not authorised the carrying out of a sporting event, social event or entertainment on the Roads and access has been restricted, said restriction being indicated by the display of Traffic Signs at such times as authorised by the City Council for reasons of public safety prior to, during and after those events.
5. Any motor vehicle proceeding in the following roads of parts of roads subject to the provision of Articles 3 and 4 of this Order shall proceed in the direction specified in relation to that road or part of that road:-
- (a) Fargate - between High Street and Surrey Street – Southwest bound;
 - (b) Norfolk Row – Northwest bound;
 - (c) Surrey Street – that area of land bounded by its junction with Fargate to a point 20 metres in a south easterly direction – Southeast bound;
 - (d) High Street – between Black Swan Walk and a point 28 metres north of Black Swan Walk – Southwest bound.
6. The Sheffield City Council (Exchange Gateway, Fargate and Norfolk Row) (Prohibition of Driving) Order 1997 is hereby revoked.
7. This Order shall come into operation on the _____, 2023 and may be cited as The Sheffield City Council (Fargate Area, Sheffield) (Prohibition of Motor Vehicles and One Way Traffic) Order 2023.

The Sheffield City Council in exercise of its powers under Section 1(1), 2(1) and (2) and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (as amended) shall have effect as though:
 - a) For Article 4 thereto there was substituted the following Article:
 4. Save as provided in Articles 7, 12C and 12F of this Order no person shall cause or permit any vehicle proceeding in the roads specified in Column 1 of Schedule 4 to this Order and in the direction specified in Column 2 of that Schedule to make a right turn into any of the roads specified in Column 3 of that Schedule.
 - b) In Schedule 4 thereto there was included the following item:

13.	Surrey Street	South	Surrey Street
-----	---------------	-------	---------------
 - c) In Part IV – Exemptions, thereto there was included the following Article:
 - 12F Nothing in Article 4 of this Order shall apply to a pedal cycle proceeding in a southerly direction in Surrey Street entering the junction with Surrey Street.
2. This Order shall come into operation on the day of , 2023 and may be cited as The Sheffield City Council (Various Roads, Central Area) (Prohibition of Driving, Prescribed Turns and Prohibited Turns) Order 1992 (Amendment No.) Order 2023.
