NOTICE IS HEREBY GIVEN that on the 20<sup>th</sup> day of July 2023 the Sheffield City Council made the above Orders which comes into operation on the 24<sup>th</sup> day of July 2023 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to introduce:

- Prohibition of Waiting At Any Time on parts of Batemoor Road - Northern Leg, Batemoor Road - Southern Leg, Dyche Lane and Dyche Road.

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 20<sup>th</sup> July 2023 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Section 1(1), 2(1) to (3), 4 (2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124 (1) (c) (d) and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:-

a) In Schedule 1.01C thereto there were included the following items:-

131E. Batemoor Road – The north west side:-  
Northern Leg

(i) From its junction with the south western kerb line of Dyche Lane for a distance of 15 metres in a south westerly direction.

The south east side:-

(i) From its junction with the south western kerb line of Dyche Lane for a distance of 15 metres in a south westerly direction.

131F. Batemoor Road – The north west side:-  
Southern Leg

(i) From its junction with the south western kerb line of Dyche Lane for a distance of 14 metres in a south westerly direction.

The south east side:-

(i) From its junction with the south western kerb line of Dyche Lane for a distance of 13 metres in a south westerly direction.

351A. Dyche Lane The north east side:-

(ii) From a point 88 metres south east of its junction with the south eastern kerb line with Dyche Road for a distance of 72 metres in a south easterly direction.

(iii) From a point 30 metres south east of its junction with the south east kerb line of Dyche Road to a point 27 metres north west of its junction with the north western kerb line of Dyche Road.

(iv) From a point 3 metres south east of its junction with the intersecting projected south eastern kerb line of Batemoor Road (Northern

Leg) for a distance of 37 metres in a north westerly direction.

The south west side:-

- (ii) From a point 16 metres north west of its junction with the north western kerb line of Batemoor Road (Southern Leg) to a point 37 metres south east of its junction with the south eastern kerb line of Batemoor Road (Southern Leg).
- (iii) From a point 3 metres south east of its junction with the intersecting projected south eastern kerb line of Dyche Road for a distance of 39 metres in a north westerly direction.
- (iv) From a point 23 metres south east of its junction with the south east kerb line with Batemoor Road (Northern Leg) to a point 8 metres north west of its junction with the north west kerb line of Batemoor Road (Northern Leg).

353. Dyche Road

The south east side:-

- (i) From its junction with the north eastern kerb line of Dyche Lane for a distance of 13 metres in a north easterly direction.

The north west side:-

- (ii) From its junction with the north eastern kerb line of Dyche Lane for a distance of 14 metres in a north easterly direction.

2. This Order shall come into operation on the 24<sup>th</sup> day of July 2023 and may be cited as The Sheffield City Council (Consolidation) (On-Street Parking and Prohibition of Waiting) (Outer Area) Order 2008 (Amendment No.161) Order 2023.
