NOTICE IS HEREBY GIVEN that Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to 2(4), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to:

- Introduce a weight limit of 18 Tonnes on part of Furnace Lane;
- Introduce a weight limit of 7.5 Tonnes on part of Meadow Gate Lane.

A copy of the proposed Order, a plan showing the roads concerned and a statement of the Council's reasons for proposing to make the Order may be examined during normal opening hours at First Point Reception, Howden House, 1 Union Street, Sheffield, S1 2SH or on the City Council Website at www.sheffield.gov.uk/home/roads-pavements/traffic-orders.

The Sheffield City Council in exercise of its powers under Section 1(1) and (2), 2(1) to 2(4), 4(2) and Schedule 9 of the Road Traffic Regulation Act 1984 (“The Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Various Roads at Sheffield) (Weight, Width and Height Restrictions) (Consolidation) Order 2009 (as amended) shall have effect as though:-

a) In Schedule 4 thereto there were included the following items:-

Column 1 – Restricted Road	Column 2 Maximum permitted weight
4B. Furnace Lane - so much as is carried by the bridge over the railway.	18 Tonnes
5A. Meadow Gate Lane - so much as is carried by the bridge over the railway.	7.5 Tonnes

2. This Order shall come into operation on the th day of April, 2024 and may be cited as The Sheffield City Council (Various Roads at Sheffield) (Weight, Width and Height Restrictions) (Consolidation) Order 2009 (Amendment No.) Order 2024.
