NOTICE IS HEREBY GIVEN that on the 28th day of March 2024 the Sheffield City Council made the above Order which comes into operation on the 2nd day of April 2024 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:-

- Prohibition of Waiting at Any Time on parts of High Street, Mosborough.
- Waiting Limited To 2 Hours, No Return Within 2 Hours Monday to Friday 8:00am-6:30pm on parts of High Street, Mosborough.
- Waiting Limited to 30 minutes, No Return Within 30 minutes Monday to Saturday 8.00am-6.30pm on parts of High Street, Mosborough.

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 28th March 2024 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Section 9 and Schedule 9 of the Road Traffic Regulation Act 1984 (“The Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Consolidation) (On-Street Parking And Prohibition Of Waiting) (Outer Area) Order 2008 (as amended) shall have effect as though:-

a) In Schedule 5.07B for item ‘2. High Street (Mosborough) – the north east side (i)’ thereto there was substituted the following item:-

2. High Street

The north east side:

- (i) From a point 12 metres south east of its junction with the projected south eastern kerb line of Stone Street for a distance of 38 metres in a south easterly direction.

b) In Schedule 1.01D thereto there was included the following item:-

1135. High Street
(Mosborough)

The north east side:-

- (iii) From a point 98 metres south east of its junction with the south eastern kerb line of Stone Street for a distance of 9 metres in a south easterly direction.

c) In Schedule 5.02A thereto there were included the following items:-

4A. High Street
(Mosborough)

The north east side:-

- (i) From a point 50 metres south east of its junction with south eastern kerb line of Stone Street for a distance of 48 metres in a south easterly direction.
- (ii) From a point 107 metres south east of its junction with south eastern kerb line of Stone Street for a distance of 36 metres in a south easterly direction.

2. This Order shall come into operation on the 2nd day of April, 2024 and may be cited as The Sheffield City Council (Consolidation) (On-Street Parking And Prohibition Of Waiting) (Outer Area) Order 2008 (Amendment No.167) Order 2024.
