STATEMENT OF REASONS

On Wednesday 19 July 2023 members of the Transport, Regeneration and Climate Policy Committee decided, in response to objections received into response to the consultation on The Sheffield City Council (Kelham Island and Neepsend)(On Street Parking Places, Loading Bays, Prohibition of Waiting And Loading) (Map Schedule) Order 2024, that additional engagement should be done within the Neepsend area –focussing on businesses – to see how the effects of the originally proposed permit scheme could be reduced.

This engagement took place in October and November 2023. A report was made to the Transport, Regeneration and Climate Policy Committee on the outcome of this on Monday 11 December 2023. At this meeting it was agreed that hours and days of operation of the parking places in Neepsend should be amended to Monday to Friday, 09:00am to 03:00pm on Bardwell Road, Boyland Street and Neepsend Lane (between Rutland Road and Bardwell Road) and to Monday to Sunday, 09:00am to 03:00pm in all other areas of Neepsend.

This Traffic Regulation Order is being promoted to maintain the free and safe flow of traffic and to improve the amenities of the area.
