NOTICE IS HEREBY GIVEN that on the 26th day of May,2022 the Sheffield City Council made the above Order which comes into operation on the 30th day of May, 2022 under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order will be to enable the City Council to control the use of car parks on land owned by Sheffield Hallam University at Aspect Court on Pond Hill and Furnival Works on Furnival Street in line with an agreement between the university authorities and the City Council.

Any person who wishes to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the enabling Act or that a requirement of the enabling Act or any of the relevant regulations made thereunder has not been complied with may, within six weeks of the 30<sup>th</sup> May, 2022 make application for that purpose to the High Court.

The Sheffield City Council in exercise of its powers under Sections 32, 33, 35(1), and Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. The Sheffield City Council (Off-Street Parking Places) Order 1979 (as amended) shall have effect as though:
  - a) In the Schedule thereto there were deleted the items ‘Science Park A’, ‘Science Park B’ and ‘Schofields Howard Lane’.
  - b) In the Schedule thereto there were included the following items:-
